- Range Facilities: 9 Rifle and Pistol ranges, turning targets with 30 shooting positions, weapons cleaning facilities, parking for 120 cars, air conditioned lunch room, bathroom/showers, administrative facilities.
- Weather: The weather in the Tri-Cities in July is usually in the 90's with very low humidity and light winds. Sun-block is highly recommended (SPF-30 or higher).
- Camping: The Hanford Patrol ranges are located on Government property and no overnight camping is allowed at the range facility. There are camping sites located within a few miles of the range. See information provided with this program.
- Lodging: Available at nearby motels and hotels. It is the competitors responsibility to make arrangements for overnight lodging.
- Food: Lunch items will be available for purchase from 12:00 to 1:00 on Saturday and Sunday for a reasonable price.
- Alcohol: Alcoholic beverages are not permitted on Department of Energy property. Violations will result in disqualification.
- Smoking: Not permitted on the firing line or inside any buildings.
- Pets: No dog's, cat's or other domestic animals are allowed on Hanford property, except on duty K-9.
- Rules: Current NRA Police Pistol Combat Rules will govern throughout the tournament.
- Eligibility: Open to any individual police member of the N.R.A. eligible to compete under rule 2.4 of the current N.R.A. Police combat rule book. You may join the NRA on the day of the tournament. Due to Department of Energy regulations, all competitors must be regular, reserve, or retired members of a recognized Law Enforcement or Military Agency. There will be no Civilian match.
- Teams will consist of two firing members, one alternate and one team captain, each team representing a police club or law enforcement agency eligible under rule 2.14. The team captain may be a firing member of the team. Each agency will be permitted to enter more than one two man team in match #7 and match 14.
- Shooting: Shooting will begin at 9:00 a.m. on Saturday and Sunday.

Time: Anyone wishing to compete must be registered prior to Saturday. Registration closes at 9:00 a.m.

Registration: Registration must be made using the "pre-entry form" attached to this program and accompanied by a check or money order in US funds made payable to Hanford Patrol Pistol Team. NRA registration cards (blue cards) will be completed by each competitor on the day of the match. Pre-entry forms and match fee's must be mailed to:

Team Match: The 2 man team match will consist of a separate Match 5 fired immediately following the 1500 match.

Squadding: All matches will be squadded, including the warm up match. Squadding tickets for individual matches will be issued from the statistical office at the time of registration. Competitors must pick-up these tickets as soon as they arrive at the range. Competitors will be squadded for the same relay and starting time on Saturday and Sunday. Target assignment may vary.

NRA membership cards and classification cards must be exhibited before squadding tickets will be issued. (Rule 19.7) A competitor who fails to obtain his squadding ticket or to present himself at a proper firing point when his relay is called may lose his right to compete in that event.

Match Format: Starting at 0900 hrs on Saturday & Sunday. Matches will be fired in the following order:

A 30 minute lunch break will be taken at around 1200 each day.

Warm Up Match: There will be a warm-up match on Friday July 9th from 9:00 am to 3:00 pm. Match #5 will be fired in approximately 30 minute intervals at a cost of \$5.00. The first match fired will count for awards in each class.

Classification: (A) Individual - Competitors will be classified as High Master, Master, Expert, Sharpshooter, Marksman, Classified, and Unclassified. Classification will be based on the NRA Police Pistol Combat classification system, the scores for which are taken from Approved NRA

sanctioned police combat pistol matches.

If there are fewer than 5 competitors in a Class, they may be combined with the competitors in the next higher class for awards purposes.

Unclassified competitors are required to compete in the High Master class (Rule 19.2) Assigned classification may be used in making entry in an NRA sanctioned tournament.

(B) Team matches will be classified (Rule 19.12)

- Challenges: A challenge fee of \$1.00 will be charged for each challenge made. NRA rules governing the challenge procedure will apply. Challenge time ends 1 hr after scores are posted.
- Arms Allowed: See rule 3.2 and 3.3.
- Ammunition: Either handload or factory loaded round nose or wadcutter .32 caliber or larger may be used. No magnum or high speed ammunition will be allowed. (Rule 3.17)
- Firing Method: D.A. will designate matches which must be fired double action. S.A. will designate matches which may be fired either double or single action.
- Loading: All loading will be with cartridges taken from the competitor's pocket, cartridge belt, mechanical loaders, or special pouch which must be on the competitor's person. (Rule 10.9)
- All loading will be with six (6) cartridges (except for the WSPPA Duty Gun Match). Time for reloading is included in the time for each match or stage. (For additional loading procedures see Rule 10.9) If a Semi Auto pistol is used, all magazines will be loaded with 6 rounds.
- Time: Time will be announced for each stage or match. Time will start with loaded gun in the holster and the shooter in the standing position with arms hanging straight down at the shooters side. No part of the competitor's hand may touch the gun until the command to commence firing is given.
- Optical Devices: No optical devices (other than normal glasses worn for corrective eyesight purposes, safety glasses, or sun glasses) will be permitted on the range during firing for use by competitors or team officials. Optical devices have also been interpreted to prohibit the use of mechanical iris, and eye patch or eye cover. For team coaches during the team match, see rule 12.6.
- Safety Equipment: All competitors and spectators are required to wear eye and ear protection while on or near the range facilities during match firing.
- Holster: A conventional right or left-handed holster must be used. For safety reasons, shoulder, cross draw or holsters which require releasing by insertion of finger within the trigger guard will not be allowed. Holster cannot be tied down. Duty holsters and duty equipment must be used for the WSPPA Duty Gun Match.
- Targets: N.R.A. B-27 target will be used. Hits in the 7, 8, 9, 10, and x, scoring areas will count.
- Sighting Shots: Sighting shots will not be allowed on either day of the match prior to or during the match.
- Refires: No refires will be allowed for defective guns or ammunition or for other malfunction of the shooter's equipment. Competitor may clear jams or malfunctions provided all safety requirements are met.
- Breaking Ties: See Rule 15.11 for tie breaking procedures.
- Match No. 1: Two stages of 12 shots fired double action from the standing without support position. First stage fired at 7 yards and second stage fired at 15 yards. Twenty seconds per stage starting with loaded gun in holster and including time to reload.

- Match No. 2: 25 yard, kneeling and standing Match - D.A. course of fire - six shots kneeling; six shots left hand from behind barricade; six shots right hand from behind barricade; all firing double action. Time is ninety seconds for entire course starting with loaded gun in holster and including time to reload. Time starts with shooter in standing position.
- Match No. 3: 50 yard sitting, prone and standing match - S.A. or D.A. course of fire - six shots sitting, six shots prone, six shots left hand from behind barricade, six shots right hand from behind barricade. Time two minutes and forty five seconds starting with gun loaded in holster and including time to reload. Time starts with shooter in standing position.
- Match No. 4: 25 yard standing without support match - D.A. course of fire two stages of twelve shots each fired double action, standing position at 25 yards. Time thirty-five seconds for each twelve shot stage starting with loaded gun in holster and including time to reload.
- Match No. 5: N.R.A. National Police Course:
- Stage 1 7 yards - twelve shots double action from the standing without support position. Twenty seconds, time starts with loaded gun in holster and includes reloading for the second six shot string.
 - Stage 2 25 yards - six shots kneeling, double action, six shots standing, double action, left hand from behind barricade, six shots standing, double action, right hand from behind barricade. Ninety seconds, time starts with loaded gun in holster and includes reloading for subsequent six shot strings.
 - Stage 3 50 yards - six shots sitting, six shots prone six shots standing left hand from behind barricade, six shots standing right hand standing from behind barricade, single or double action. Two minutes and forty-five seconds time starts with loaded gun in holster and includes reloading for subsequent six shot strings.
 - Stage 4 25 yards - six shots standing without support double action. Twelve seconds, time starts with loaded gun in holster. No barricade or other support is used.
- Match 6: Aggregate of matches 1-5
- Match 7: Revolver Team Match. Same as Match #5
- Match 8-12: 1500 Semi-Auto pistol. Same as Match 1-5
- Match 13: Aggregate of matches 8-12
- Match 14: Semi-Auto Team Match. Same as Match #12.
- Match 15: Off Duty Gun Match. (NRA Revolver or Semi-Auto Classification will be used)

Firearm: A .38 caliber revolver firing 158 grain service ammunition with barrel length not to exceed 2 ¾" with fixed or adjustable rear sights. See NRA Rule 3.6. Or, if firing a Semi-Auto pistol it must be a .380 caliber or larger, fixed sights only, and a barrel length no longer than 3.65". See NRA Rule 3.8.

Course of Fire:

Stage 1 3 yards, double action, 6 shots one hand standing without support, 8 seconds.

Stage 2 7 yards, double action, 12 shots standing without support, 20 seconds.

Stage 3 15 yards, double action, 12 shots standing without support, 20 seconds.

Stage 4 25 yards, double action, 18 shots in 90 seconds. 6 shots kneeling using the barricade, 6 shots standing left hand from behind the barricade, and 6 shots standing right hand from behind the barricade.

Match 16: 4" Service Revolver Match. (NRA Revolver Classification will be used)

Firearm: A .38 caliber revolver firing 158 grain lead service ammunition with a barrel length not to exceed 4". Fixed or adjustable sights and no external modifications except for grips (not a competition firearm). See NRA Rule 3.5.

Course of Fire: Same as Match #15 Off Duty Revolver course.

Match 17: WSPPA Duty Gun Match.

Firearm: Revolver or semi-auto. However it must be the same manufacturer, model number, and barrel length as carried on duty and authorized by the appropriate law enforcement agency. Retired officers may compete with the same firearm type that they carried prior to retirement. Ammunition, holsters, and ammunition pouches, must be a type that is authorized for duty use.

Course of Fire:

State 1 5 yards, fire 3 shots in 3 seconds. Repeat for a total of 6 rounds.

Stage 2 7 yards, start in the low ready position and fire 2 shots in 2 seconds. Repeat 2 times for a total of 6 rounds.

Stage 3 15 yards, 12 shots in 20 seconds

Stage 4 25 yards, 18 shots in 60 seconds. Fire 6 shots kneeling using the barricade for cover and support, 6 shots standing left hand barricade, and 6 shots right hand barricade.

Stage 5 7 yards, 6 shots in 6 seconds.

Match 18: Individual Championship match. Aggregate of the Revolver 1500 and Semi-Auto 1500 (Match 6 and 13)

Awards: The awards for revolver matches will be presented after the Saturday evening dinner banquet. The awards for the Semi-auto matches and the aggregate matches will be presented at the Hanford Patrol Training Academy on Sunday as soon as possible following the last match of the day. The awards will be the same as listed below for the Revolver matches, in addition to the awards provided by the NRA;

Major awards for all matches will be Home Depot gift certificates.

Match 6 & 13: Match Winner, 2nd and 3rd aggregate, one award per five shooters in each class.

Match 15, 16, and 17: Match winner and one award per five shooters in each class.

Match 18: Grand Aggregate (Match 6 and 13 combined) Match Winner, 2nd and 3rd aggregate, High Female, High Canadian, and one award per five shooters in each class.
